

## **Planning Appeal - Ref: UTT/21/2509/OP**

### **Re: Statement on behalf of Residents of Swards End dated 22nd May 2022 ("The Statement")**

#### **Summary of the results of the Petition organised in support of The Statement**

##### **1. Introduction**

During the course of the preparation of The Statement on behalf of Residents of Swards End, dated 22nd May 2022, a petition was organised to show the depth of feeling amongst residents of Swards End and the wider local area, including Saffron Walden, who are opposed to the proposed development of 233 residential dwellings on land south of (east of Griffin Place), Radwinter Road, Saffron Walden. The petition was open for a period of 4 weeks throughout June 2022.

##### **2. Data collection**

A summary of how the petition was organised and the data collected can be found below:

- a) A list of residential properties in the village was collated using the latest Electoral Roll for Swards End.
- b) Signatures from residents in Swards End were collected during June:
  - in person, by knocking on doors
  - in person at various Jubilee events in the village
  - via publicising the petition on the village Facebook group
- c) An online petition was set up on Change.org and was publicised on local Facebook groups.  
*N.B. The online petition was only open for approximately 10 days.*

##### **3. Results**

- a) Total number of signatures received: 585 (399 collected in-person, 186 collected via the online petition)
- b) Total number of residential properties in Swards End: 216
- c) Number of properties visited in Swards End: 170
- d) Percentage of properties in Swards End represented by signing the petition: approx. 80%
- e) Percentage of individuals who declined to sign the petition: less than 2%  
Reasons given - temporary rental and did not feel it was appropriate to sign
  - never signs petitions on any subject matter as a point of principle
  - Please note: no one stated that they were in favour of the development
- f) Percentage of properties in Swards End that we were unable to contact: approx. 18%

Our 'hit rate' from making direct contact with households in Swards End suggests that, had we been able to reach every property, more than 95% of village residents would show their opposition to this development. A similar level of opposition is demonstrated by signatures collected in person from residents in Radwinter Road, Saffron Walden, who will be directly, adversely affected by the increased traffic this development would produce.

g) Comments provided/key concerns of those who signed the petition:

- lack of appropriate infrastructure and insufficient highway capacity to support additional traffic in and around Saffron Walden. This was clearly highlighted when an incident occurred in mid-June which resulted in Radwinter Road being closed to all traffic from Elizabeth Way to the junction with Thaxted Road for 4 days while emergency repairs were made to the water main. This had an enormous negative impact on all the other routes into and out of Saffron Walden, as well as the surrounding villages and small, narrow country lanes, which are the only alternative routes around the town, causing major traffic congestion and delays.

- insufficient medical facilities (including GP surgeries and dentists)
- lack of additional school places – local schools are already at capacity
- loss of village status for Swards End
- damage to the environment and the detrimental effect on air quality
- lack of jobs within Saffron Walden will necessitate new residents travelling across the town to reach Cambridge, Bishops Stortford, London or elsewhere to their place of work.

#### **4. Conclusion**

The strength of feeling of local residents is overwhelmingly against this development. The results of our petition support the conclusion in our original Statement, previously submitted to the Planning Inspectorate, that the town 'is already at breaking point from the point of view of its resources and amenities'. No-one we approached is in favour of the development.

If this development is allowed to go ahead, the detrimental effect on residents, the environment, wildlife and our community will be devastating. It must be rejected.
